GRANT COMMITTEE UPDATE

As you may know, WJCIA was able to sponsor a number of trainings using grant funding through DOJ (Kevin Rathburn training in November 2020 on Amendments and Use of Force and Carey Guides/BITS training in December 2020).

After the training, \$4,193.95 remained of the grant and is available until 9/30/2021. A number of options were considered. With the remaining funds, it was decided to make a request to send Melissa Zarczynski (current Board President) and Renee Handrow (past Board President) to a national conference for training. Robert F. Kennedy Transformation of Youth Justice Symposium: Expanding Knowledge, Changing Practices, and Achieving Outcomes will be held 9/8-9/9/2021 in Nashville, TN. Having representatives at the national conference will allow our organization to expand the topics that we consider for our own conference held annually in September.

In addition, there may be grant monies remaining after the national conference to purchase Carey Guides for any counties that are in need of the resources. Please reach out to any of the board members if you are in need of Carey Guides binders.

Through WJCIA, an advertisement to recruit individuals interested in being trained as trainers in Carey Guides/BITS Training has been posted through 7/9/2021. The Grant Committee will be continuing to look for funding to move forward on this initiative in order to continue to provide Carey Guides/BITS training in Wisconsin.

Division of Juvenile Corrections Updates

Lincoln Hills/Copper Lake School has implemented a Mystery Motivator program in the Education Department. With help from the PBIS committee, Brandi Berry (School Psychologist-Senior) and Alan Koeller (Special Education Teacher) recently piloted this program in order to provide both individualized and class-wide incentives contingent on students' demonstration of positive, prosocial behaviors. This evidence-based intervention has been shown to significantly decrease disruptive behaviors in educational settings. By varying the criterion of the day (e.g., showing respect to others, asking for help appropriately) and the incentives, students at Lincoln Hills and

Copper Lake have remained engaged and committed throughout the unrolling of this program. At this time, the Mystery Motivator program has been implemented school-wide and has been very well received by students and staff alike. Some favorite incentives thus far have included classroom competitions, milk and cookie breaks, and collaborative art projects.
