History/Background:

The Wisconsin Juvenile Court Intake Association is an independent, professional organization established to provide support, training and a common sense of purpose for juvenile court intake workers as individuals and as a professional group. WJCIA recognizes that many Wisconsin counties are utilizing Carey Guides and BITs as a case management tool to address youth's dynamic risk factors and with grant funds, WJCIA was able to offer/support training in this area for several years. Currently, we realize it is not cost effective

to continuously hire a trainer from The Carey Group to provide this training.

As a result, WJCIA is currently investigating funding options that will allow us to train a pool of individuals in Wisconsin that will provide Carey

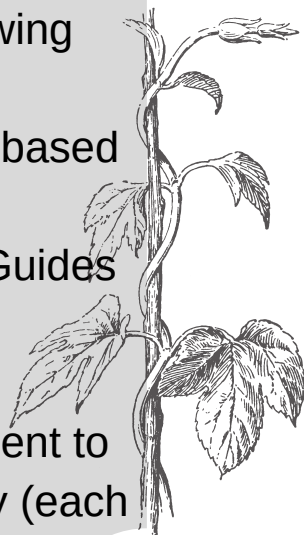
Guides and BITs training to Wisconsin counties on an ongoing and regular basis. Although funding has not been secured at this time, WJCIA would like to begin by identifying up to 12 individuals to fill this need in Wisconsin.

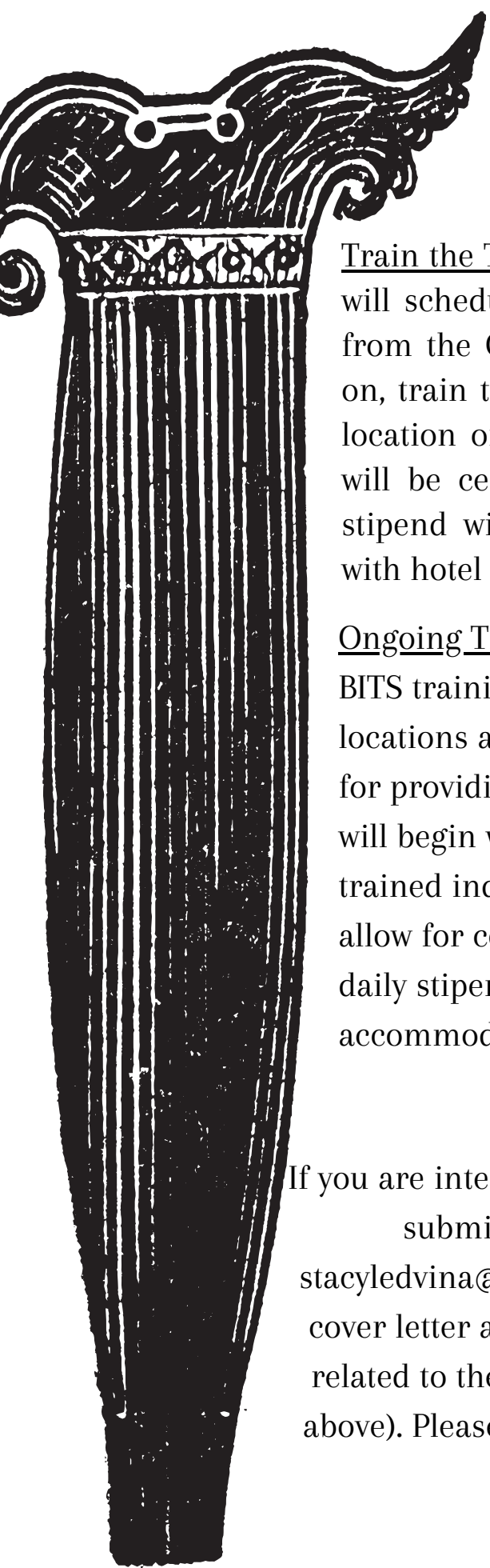
Requirements

WJCIA is accepting resumes from individuals who have an interest in being considered for one of twelve Train the Trainer slots.

Applicants must meet the following requirements:

- Knowledge related to evidence-based principles in youth justice
- Experience utilizing the Carey Guides and BITS
- Skills in training professionals
- Flexible schedule and commitment to providing training twice annually (each training is 2 days)





DETAILS

Train the Trainer (TTT) details: Once funding is secured, WJCIA will schedule a 4 day TTT through The Carey Group. A trainer from the Carey Group will provide 4 days of in-person, hands on, train the trainer materials for up to twelve individuals. The location of the training will be determined at a later date and will be centrally located based on participants. A small daily stipend will be provided to individuals who participate, along with hotel accommodations (if necessary), and meals.

Ongoing Training Details: WJCIA will schedule Carey Guides and BITS training on an ongoing and regular basis in various locations around the State. Trained individuals will be responsible for providing the two 2 day training. We anticipate that training will begin with 2 trainers/co-trainers present, to allow newly trained individuals to get comfortable with the materials and to allow for coaching and feedback to occur when training is new. A daily stipend will be paid, along with necessary hotel accommodations and reimbursement for meals.
