#### Serving CSEC Survivors

This presentation will further define human trafficking and its dynamics related to engaging in youth in services. This presentation will provide practical ways to create programs for youth who have been impacted by trauma and exploitation.

#### **Building Resiliency in Children**

Resiliency is a buzz word when discussing trauma, but to actually build resiliency in children, takes skill and a different approach than is often used. This training will teach the audience member about the impact trauma has on neurobiology in children and how to use neuroplasticity to build resiliency. The audience members will learn real life approaches and tools to use while working with youth and their families to have better outcomes with youth who have experienced trauma

#### **Immature Adolescent Brain Development & Crimes Likely** Influenced by the Immaturity & Which Crimes are a Product of Deeper/More Severe Problems\*

Biographical Info: Dr. Anna C. Salter is in private practice and consults to the Department of Corrections in Wisconsin. She has assessed and treated adolescent sex offenders for the past thirty years. In addition, she has helped develop curriculum for treatment of adolescent sex offenders both within secure juvenile facilities and in the community. Dr. Salter has written three academic books on sex offenders as well as five mysteries.

#### **Making Graduated Responses Work**

Using graduated responses is an effective way to address technical violations of court ordered rules of supervision. This workshop will outline what graduated responses in youth justice are and are not. Current research on graduated responses and outcome data will be discussed. Sample response grids and policies currently being utilized in Wisconsin will be provided.

Youth Perspective on the Youth Justice System Youth from the DCF Youth Leadership Teams from across the state will share their personal experiences and perspectives on the youth justice system. They will share their ideas about what works and what doesn't, and the type of youth justice system that they want to help create. They will share specific guidance for intake workers about how to work most effectively with youth.

#### **QPR: Suicide Prevention Gatekeeper Training**

QPR is intended to teach people to recognize the warning signs, clues and suicidal communications of people in trouble and to ACT vigorously to prevent a possible tragedy. A gatekeeper is anyone

trained to recognize a suicide crisis and, because of their training, knows how and where to find help. QPR gatekeeper training takes just one hour and is taught in a format that is clear and concise. Gatekeepers are given information that is easy to understand and reinforced by a QPR booklet and card complete with warning signs and methods to encourage a person to get help.

#### **Interstate Compact for Juveniles**

Delinquent youth need to be safe and accountable even when they cross state lines. The Interstate Compact for Juveniles is a nationwide agreement to assure kids are safe and communities are protected. This session will introduce the Compact - why it exists, what it does, and the role of counties in assuring Wisconsin is in compliance with the Compact rules. When you are allowing a delinquent youth to move out-of-state, supervising a youth from another state, or assisting in returning a runaway who crossed a state line, knowing how the Wisconsin ICJ office can help will be crucial to our success.

#### Gentle Yoga and iRest<sup>®</sup> Meditation

Cultivate resiliency and enhance self-care through the practice of yoga. This practice will begin with 15 minutes of gentle yoga to release tension and restore movement in the body after sitting all day. This will prepare the body for entering into states of deep relaxation and meditation while remaining aware and alert. The guided meditation will focus on meeting, greeting, welcoming, and engaging thoughts, emotions, and beliefs that arise as messengers in our lives. During iRest we realize that qualities of peace, well-being, joy, love, kindness, and compassion are always present, even during our greatest difficulties. This practice can be done while sitting in a chair or lying on the floor. Bringing a yoga mat, blanket, towel or small pillow, and eye covering could make the experience more enjoyable but are not necessary.

### **Building a Better Man: Reducing Violence and Increasing** Pro-social Behavior in Our Young Men\* The keynote will engage the audience in a multicultural exploration of influences impacting the

socialization of young men involved in the juvenile justice system. The Masculinity Development Hierarchy will be introduced as a conceptual framework by which to characterize these influences. This will be followed by a description of the Building a Better Man intervention, a science-based positive masculinity approach that applies this theory with the goal of reducing violence and increasing prosocial behavior. The presenters will help the audience integrate their understanding of the model and apply it to their work with young men to effectively address violence prevention/reduction.

#### Ethics & Boundaries
