
BECOME A BOARD MEMBER!!!!

Facebook Ate My Daughter, and Now My Son Won't Stop Playing Call of Duty: what professionals need to know about social media

The most recent research suggests that the more time a girl spends on Facebook, and the more Facebook friends she has, the more likely she is to become anxious or depressed. In this presentation we consider how social media are changing the patterns of teenage offending, especially for girls.

Boys Adrift: why have so many boys tuned out?

The key is to make the school, and the community, more boy-friendly without making it unfriendly to girls. The key to successful intervention with these boys is to re-motivate them, to re-connect them with the real world.

Why Gender Matters: sex differences in the propensity to delinquent behavior

Teenage girls and boys in the United States are now equally likely to abuse alcohol. Understand gender differences – with regard to smoking and with regard to alcohol, illegal drug use and other delinquent activities.

Risk & Needs Assessment: supporting effective practice agency wide

This presentation will review characteristics of good assessments and how assessment findings can be used to improve practice throughout an agency.

In A New Light-The Use of Expressive Arts as a Transformative Tool for Troubled Youth

An interactive presentation that discusses history, types and effectiveness of expressive arts and it's a practical use in rehabilitation of troubled youth using research and anecdotal data.

The State of Juvenile Justice in Wisconsin: what do we really know and where do we need to go?

This session will include data about the remarkable decline in the number of youth placed in detention/secure correctional facilities, the number of youth arrested as well as present some ideas about how to communicate to the public and policy-makers about the need to invest in and strengthen our juvenile justice system.

Maximizing Your Intake Interview

Presenter will take a comprehensive look at the various components of the Intake Interview as required under 938.243. The five parts of the interview will be discussed: obtaining basic information, informing the juvenile of their constitution rights, explaining the possible dispositions, assessment of needs and making a decision. The presenter will examine the underlying messages that a family is sending; what messages are you sending to the family; and are you having an impact.

The Seven Essential Ingredients of Trauma Informed Care

This presentation will overview the seven essential ingredients of trauma informed care. Participants will learn the high prevalence of traumatic events in the lives of children we serve as well as the potential impact that these traumatic events have on children in areas such as health, neurodevelopment, learning and behavior.

Social Workers and the Yellow Brick Road

Following the “Yellow Brick Road” can be difficult at times as we choose which fork to take, which pot holes to avoid and the quickest way to get there! Learn to deal with life’s “GPS”, turn on the self-motivation inside you; boost your self-esteem; empower yourself; and achieve your goals along the way.

Social Worker’s: making a Case for Safety

Learn to identify strengths by learning to listen more attentively; recognize the breaking point of family members during visits; recognize potentially dangerous situations; recognize and demonstrate how to safely defuse a volatile situation; understand what simple techniques can be used to defend yourself if necessary.

Engaging Absent Fathers

Fathers have a critical role in the lives of their children. This will focus on the importance of having fathers involved with youth and the negative implications if they are not. Learn numerous resources available on ways to locate and involve fathers. Strategies will be shared on ways to engage fathers into the juvenile justice process and working with incarcerated fathers.

Secondary Traumatic Stress and the Juvenile Justice Worker

Juvenile Justice Workers and police officers are directly and personally affected by the emotional stressors that accompany their day-to-day work. Learn about Secondary Traumatic Stress (STS) and burnout. Individual coping skills and social support strategies will help minimize the negative impact of STS personally and professionally.

Programming and Services at Lincoln Hills & Copper Lake School

There have been many changes with the consolidation of youth in Wisconsin Correctional Institutions. Programming, education and other services will be shared.

Transformations-Changing our interventions to match our brains utilizing HeartMath

The S211 form must be presented instead of the company's tax exempt certificate. The tax exempt company/agency must be paying for the overnight stay. If the guest is paying and getting reimbursed, then they must have a letter on letterhead from the tax exempt organization specifically naming that person being on company business and will be reimbursed by the tax exempt organization.
